AN ORDINANCE AMENDING ORDINANCE NO. 2007-08 IN ORDER TO AUTHORIZE THE NET COLLECTIONS OF THE 1.5% SALES AND USE TAX LEVIED WITHIN THE CITY OF ATKINS, ARKANSAS BY ORDINANCE NO. 2007-08 TO BE USED TO PAY AND SECURE THE REPAYMENT OF BONDS APPROVED BY THE VOTERS AND ISSUED BY THE CITY FROM TIME TO TIME TO FINANCE AND REFINANCE CAPITAL IMPROVEMENTS; AND PRESCRIBING OTHER MATTERS RELATING THERETO.
